The Township of Southampton welcomes you to join us for the Arts in the Village Market Day. The Vincentown Village is an idyllic setting for the community to gather with artists/crafters/vendors for a family friendly event. There will be many people selling their wares: art, crafts, plants, books, food and yard sales on Main Street. Some historic buildings will also be open. Main Street will be closed that day between Mill Street and Race Street.

## General guidelines and information for artists:

All items to be displayed and sold must be handmade by the artist or by the exhibitor who is actively selling in the booth. No direct sellers are allowed. Anyone found selling non-conforming products must immediately remove those items from their booth upon request by a member of the Committee.

- ❖ Exhibitors must keep their displays open for the duration of the event.
- ❖ If there is a chance of rain or postponement due to inclement weather, the committee will post the change on the Arts in the Village Facebook page by 8 pm on May 13. Emails will also be sent out to notify vendors. There will be no refunds if the event is canceled in its entirety due to inclement weather on Sunday, May 15.
- ❖ The Committee is not responsible for damage to, or theft of, exhibitor's products or booth display.
- ❖ You must supply your own canopies, tables, chairs and supplies.
- ❖ There is \$20 fee for the 10 x 10 foot space which will be assigned on Main Street. Checks to be written out to Southampton Township.
- ❖ Carry in/carry out! You are responsible for the removal of all trash and debris from your exhibit or display.

Our committee of volunteers will meet frequently prior to this event. You will be notified as soon as the Committee has approved your application. Notification of space assignment, arrival times and additional instructions will be supplied prior to the event. Thank you for being part of Arts in the Village Market Day.
