#### PRIVILEGE OF THE FLOOR:

Doug Meligari, 219 Burrs Mill Road – inquired about the budget regarding the average assessed home value. Mike Mikulski responded that approximately 14 % of taxes collected are to support the township.

Larry O'Rourke, 57 Mayfair, Board of Trustees – mentioned that the grass on the islands in LeisureTowne are very high and requested a regular mowing schedule.

Jeff Hicks, 152 Main Street – Board of Education meeting will take place on May 23<sup>rd</sup> and the school will hold a festival on May 26<sup>th</sup>. He thanked the committee for allowing him to be on the parade committee. STEA settled.

Jim Heffernan, Vincent Fire Co. - reported on calls for service and stats for the month.

Carol Deklerk, 2 Thames Court, noted that the tennis courts at the Municipal Complex have pickle ball court lines marked as well and it is confusing.

Eammon Ruth-Fitzpatrick, HLEMS – reported on calls for service and stats for the month. He also updated about an accident. A new EMT, Rebecca has finalized all her classes for EMT. She will sit for the exam. Grids were updated, public education classes in LeisureTowne started on May 13 and were well attended. Second rig will be housed at the Township Building from June to September on Monday, Wednesday and Friday from 8 am to 8 pm.

In addition as OEM – no incidents to report, 2021 requirements for EMMA were met, 2 classes were held in LeisureTowne and were well attended. Fire wise meeting in LeisureTowne, evaluation drill for the school.

Pat Topham, 450 New Road – mentioned that in Old Town Hall, the Historic Society held their annual strawberries and ice cream.

#### ADMINISTRATOR/CLERK:

Due to the Memorial Day Holiday recycling will be collected on Tuesday, May 31<sup>st</sup>. Construction to begin on crosswalk on Main Street.

#### **COMMITTEE REPORTS:**

Committeeman James Young – the Grand marshal of the Memorial Day Parade will be Ben Trimble, he is a retired veteran of WWII.

Deputy Mayor Elizabeth Rossell – Historical Society provided the 3<sup>rd</sup> grade students of Southampton and Tabernacle with their annual walking tours of Vincentown. Wished everyone a Happy Father's Day.

Committeeman Heston – Thanked James Young for raising additional funds and now the Veteran's Luncheon will be a hot luncheon. Noted that the Southampton Memorial Day Parade is the oldest continuous parade. It is held rain or shine. They will meet at the memorial at the ballfield at 8:00 am on Red Lion Road and continue to the Baptist and Methodist Cemeteries and the Grange memorial. The parade will begin at 10:00 am. He also noted that the new trash truck has lift. He mentioned purchasing 95 gallon carts which run about \$80 to \$90, there is a company that you can lease to own, we could purchase large/small, depending upon what color cart is decided but I want to add there is an additional cost for red.
