Comments from the Public:

Patrick Kennedy from 11 Retreat Rd: Who owns/maintains the sewer system? Residents have to pay for a sewer system that is only used by the Village of Vincentown. Mayor Mikulski: every resident is paying a portion and it benefits the entire township.

Elaine Kennedy from 11 Retreat Rd: Why is the American Rescue Plan Act money is not being used for the sewer. Mayor Mikulski: money is being used for roads and wastewater issues.

Phyllis Fisher from 12 Pleasant Street: The sewer is the best thing to happen to Vincentown. Sewage

backed up into the streets before it was in place.

Tom Haluszcak from 792 Westminster Drive: Requested clarification on his bill for the sewer costs. It was explained that his sewer is Pinelands Waste Water and he would seek that information directly from Pinelands Wastewater.

Committeeman Heston commented on the sewage issues before the system was in place.

No further discussion the public portion was closed.

Susan Costales, 21 Picardy Place: complained about her high water bill in Leisuretown.

Jim Heffernan, Vincent Fire Department: Reported for Vincent Fire Department the calls for service and assistance.

Eamoon Fitzpatrick-Ruth reported on Hampton Lakes Emergency Squad: Reported on calls for service. 66% calls were handled by 2nd truck at Township building. Members cleared all training. Ambulance 1783 may come in earlier than expected. Advertising for a full time EMTs. Stated he would like to see changes for LOSAP to include volunteer EMTs.

Eamonn Fitzpatrick-Ruth, OEM Management: Fire Prevention the Wildfire Plan is being updated to enable the Township to qualify to apply for NJ Forest Fire Grant. In addition the registered ready for disability or special attention during an emergency is being updated. Community Resilience Grant to address flooding and wildfire was applied for. Assemblyman It was stated Assemblyman Torrissi can help with State Grants.

No one else wishing to be heard. The public portion was closed.

ADMINISTRATOR/CLERK:

The Project on Retreat and Burrs Mill Road is winding down and the road is open at night to go through. Meeting with Vortex for Falcon Drive project will begin soon. Getting materials for the project will take a while.

Ron Heston inquired about fees for fire alarms. No fees. Arts in the Village September 24th from 9 am to 3 pm.

James Young stated at the last concert they honored Debbie Ware from Evergreen Dairy Bar for her donations to the concerts.

Elizabeth Rossell: Library Art Sale - September 30th 5 pm to 8 pm and October 1st 1 pm to 5 pm. Morning Stars Program for younger children is October 3rd. She thanked the participants of golf tournament. Department of Environmental protection has paperwork on how to avoid deer and beech leaf disease awareness.

Michael Mikulski: voting locations moved back into Leisuretown. Tax bills were sent out. He stated panic calls about possible new construction of strip malls.
